

- October Open up the grant application
- January 13 Due date for applications

This proposed timeline would move the approval date up one month from February to January compared to last year's timeline. This would allow grantees more time to complete projects and give the board additional time to solicit projects if there was any unallocated funding.

ISSUE: 2020 IFA Compliance Audit

REPORT: Report on the compliance audit from IFA on the 2020 grant award.

BACKGROUND:

Staff received a letter on July 11 from IFA requesting income and asset verification documentation for projects funded with the 2020 IFA award. Staff sent letters to the identified grantees of Jasper County Habitat, Marion County Habitat, and the HEAL House requesting documentation. The following are copies of letters and documentation received to date.

After review, it appears that there are some concerns with the application process that grantees are using. Specifically, the applications and documentation collected for beneficiaries. IFA requires that specific sources of income and assets are requested.

In the Summer of 2020 staff invited Laura Abbott from IFA to give a presentation on the requirements of HTF dollars and what is needed for the income and asset verification process. Laura is the compliance auditor for the State HTF program.

CIHTF and SCHT grantees attended virtually and were given an opportunity to ask questions. Example documentation provided by Laura was also sent out.

To ensure CIHTF compliance with IFA rules staff sent an e-mail to all current grantees requiring them to submit a copy of their application and income and asset verification documentation before funds will be released. It will only be required one time, but it will help ensure IFA compliance for the organization.
